Actuators with appliance cables are numbered.
$\uparrow$ Provide overload protection and disconnect as required.
4 Two built-in auxiliary switches ( $2 x$ SPDT), for end position indication, interlock control, fan startup, etc.
4 A. Actuators may be powered in parallel. Power consumption must be observed.
48. Parallel wiring required for piggy-back applications.

4 Apply only AC line voltage or only UL-Class 2 voltage to the terminals of auxiliary switches.
Mixed or combined operation of line voltage/safety extra low voltage is not allowed.
Meets cULus requirements without the need of an electrical ground connection.
